**NOW THE DEED OF TRUST WITNESSES AS FOLLOWS:**

1. Name of the trust : The name of the trust shall be "THIRUGNANAM EDUCATIONAL TRUST"
2. Office: No.26/1, South Car Street, Srimushnam PO & T.K, Cuddalore District – 608 703.

**TRUSTEES:**


The founder of the trust shall be the permanent Managing Trustee for life and after him one of his legal heirs shall occupy the vacancy. (As nominated by the Managing Trustee)

The Managing Trustee shall be the correspondent for all schools under the Trust and the secretary for all colleges managed by the Trust.

**OBJECTS:**

**The Objects of the trust are:**

- (a) To open, to run and to maintain Schools, Arts and Science Colleges, Polytechnic Colleges, Engineering Colleges, Physical Education Colleges, paramedical Colleges, Medical Colleges Computer Education Centers, Industrial Training Institutes, Teacher Training Institutes, and other such institutions
- (b) To found, to establish, to manage hostels, boarding homes, auditoriums, museums, laboratories, libraries for the purposes aforesaid.
- (c) To award scholarships and prizes for the deserving poor students.
- (d) To support and motivate deserving students from other institutions.

- (e) To do generally all lawful things as may be required for all or any of the above objects.
- (f) To accept corpus, donations, endowments, gifts, devises, bequests and subscriptions for all or any of the purposes of the Trust.
- (g) To collect charges such as fees, rents or other money from the beneficiaries of the courses, hostels, staff quarters, or otherwise having use of the same as may be deemed necessary at rates to be fixed by the Trust from time to time.
- (h) To purchase, sell, transfer, construct, manufacture, take on lease or otherwise acquire rights on any property for facilitating the achievement of any of the above objects.
- (i) And to do all activities which are conducive for the advancement all of the above objects.


All the above objects shall be carried out without any disparity of caste, creed or religion and shall be for general public utility.

The Managing Trustee is empowered and authorized to raise loans, as and when necessary for the proper running of the Institutions and to move the respective Universities, other Concerned Authorities and the Government for obtaining sanction and approval for establishing and running institutions.

Tuition fees paid by the students in all educational institutions of the trust shall be included for claiming exemption, as instructed in the provisions of section 80c of the Indian income tax Act, 1961.

Provided that all such objects of the trust shall be those treated as Public and Charitable and exempt for the purpose of exemption under the provisions of the Indian Income Tax Act, 1961 and or the other direct taxes and shall not include application of the funds of the Trust in violation of the provisions of section 13 of the Indian Income Tax act or any other acts as may be applicable to the charitable Trust, the income of which is exempt as they now stand and as may be amended from time to time.




**POWER AND DUTIES OF THE TRUSTEES:**

1. The Managing Trustee shall have power to make and prescribe rules and bye-laws for regulating the works of the Institutions to be started for carrying out the objects and for any other matters incidental for the working of the Trust and from time to time modify, alter or delete such bye-laws rules provided that no such bye-laws or rules shall be in any, be way contrary to the objects of the Trust.
  
2. The Managing Trustee shall have the following powers:
  - (a) To administer the trust properties in the best interest of the Trust.
  - (b) To sell, lease out, mortgage, to borrow, to raise loans or otherwise dispose of any property either movable or immovable and belonging to the trust.
  - (c) To institute, conduct, compromise or otherwise settle, or abandon any legal or other proceedings in respect of any claim by or against the Trust, Trustee or its employees in any matter.
  - (d) To accept any donation, contribution or subscription in cash or in kinds of gift properties both movable and immovable. The Managing Trustee shall have powers to receive any grants from the Central or State Government or other Trusts or Institutions.
  - (e) The Managing Trustee shall be entitled to take all steps that may be reasonable or necessary for the preservation of the Trust and Trust properties and shall power to do all such acts, thinks and matters to achieve the objects of the Trust.
  - (f) To delegate any power as the Managing Trustee, can lawfully delegate to any other person, employee, attorney or trustee and to withdraw any power of revoke any appointment of any person employee, attorney or trustee.
  - (g) Being the secretary of the Trust Institutions run by the Trust the Managing Trustee shall make all correspondences connected with and such correspondences shall be in overall management of the institution.
  - (h) After the life time of any present Trustees, the Managing trustee shall elect any person and nominate as Trustee.



**PROCEEDINGS OF THE TRUST:**

- (a) The Trustees may meet as often as may be necessary on the requisition of the Managing Trustee of the Trust. The quorum for the meeting shall be two.
- (b) The Managing Trustee of the Trust shall preside over all the meetings of the board of Trustees
- (c) In case of resolution which is to be made in the trust, the opinions of the Trustees will be considered but the decision of the Managing Trustee will finally prevail among the opinions of contrary or those inconsistent with the aims, objects and welfare of the Trust.
- (d) The Managing Trustee shall also be competent to pass any resolution by circulation among them and this shall be ratified at the next meeting or the next adjourned meeting of Trustees.
- (e) Any decision taken by the majority of the Trustees including the Managing Trustee at any Trust meeting shall be valid and binding on all the Trustees who are absent.
- (f) A Minute book shall be maintained at the office of the Trust, minutes of all meetings, appointment and entry into the office of every new trustee and all other proceedings of the Trust shall be entered and recorded in such minute books and shall be signed by the Managing Trustee either at the conclusion of the meeting or at subsequent meeting when the minutes are duly confirmed.
- (g) The Managing Trustee is entitled to appoint chartered accountants, legal advisers and such other professionals on terms as the Managing Trustee deems fit from time to time,

**FUNDS OF THE TRUST:**

The funds of the Trust are as under:-

- a) The Initial contribution of Rs.1000/- (Rupees One thousand Only)
- b) Income from the initial contribution.
- c) Any other contribution that may be received by the trust from time to time

d) Any grants or contribution that may be made by the Central/state Government.

e) All the abovesaid funds shall be assets of the trust and all movable and immovable machineries and equipments acquired by the trust shall also be treated as properties of the trust.

#### **BANK ACCOUNTS:**

Accounts shall be opened with Banks in the name of the Trust and such accounts shall solely be operated by the Managing Trustee of the Trust. The Managing Trustee may nominate any other person who works in the trust or institutions run by the trust to operate such bank accounts.

#### **BOOKS OF ACCOUNTS:**

Books of accounts for all transactions shall be kept properly and shall be audited every year by a Chartered Accountant.

The financial year of the Trust shall be from 1<sup>st</sup> April to 31<sup>st</sup> March following:

All books of accounts and records shall be in the custody of the Managing Trustee.

All the documents which may be executed by the Trust shall be signed by the Managing Trustee.

#### **ADMINISTRATION:**



The board of trustees shall have full power and authority to administer the trust, its properties and affairs and to do all acts, deeds and things which are calculated to fulfill the performance for which the trust is established. The board of trustees shall act through the Managing trustee.

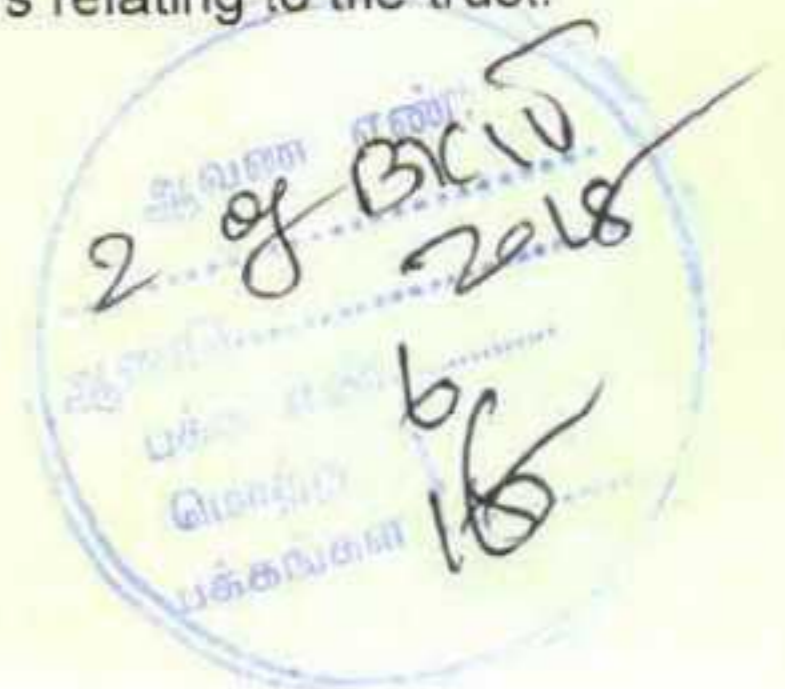
#### **QUORAM:**

The minimum number of trustees to be present for conducting a meeting of the Board of trustees shall be 1/3<sup>rd</sup> of the total number of trustees or two whichever is less.

#### **VOTING:**

Each trustee shall have one vote. The opinion of the majority of the board of trustees present at a meeting shall be final in respect of all matters relating to the trust.

**LIABILITY OF TRUSTEE OR TRUSTEES:**

In the professed execution of the trust and powers conferred, no trustee shall be liable for any loss to the trust properties arising by reason for improper investment made in good faith or for the negligence of fraud of any agent employment of such shall not strictly be necessary or expedient or by reason of any mistake or omission made in good faith by the trustees or by fraud on the part of the trustees, who alone may be subject to be made so liable.

**GENERAL:**

1. The income of the Trust and funds of the Trust shall be solely utilized towards the objects of the Trust and no part of it will be utilized for payment to the trustees by way of profit, interest and dividend etc.,
2. In the event of dissolution of the above said Trust, the assets of the Trust as on date of dissolution shall be transferred to another educational Trust having similar objects having the benefits of Section 80G of the Income Tax Act.
3. Any deletion, addition, or modification in the above rules shall be made only with the prior approval of the Commissioner of Income Tax. The provision of the Indian Trust Act shall apply in cases where express provisions are not made in this deed.
4. Subject to the aforesaid the Managing Trustee shall have powers from time to time to make and alter or amend the Rules and Regulations made with regard to the conduct of the Trust and all matters in respect of which any power or duty is hereby vested in HIM as HE thinks proper.
5. If the Trust fails for any reason in the opinion of the Managing Trustee the net assets of the Trust both movable and immovable shall be handed over to any other educational trust having the same objects of the Trust with the approval of the founders and Authors of the Trust as may be decided by the



